## DEFENDANT'S PLEA AND REQUEST FOR A DRIVING SAFETY COURSE

I hereby enter my appearance on the complaint of the offense of \_\_\_\_\_\_; by mail (or personally delivered). I understand that I have a right to a jury trial. I hereby waive my right to a jury trial, decline my right to review documents or evidence in my case, PLEAD NO CONTEST, and Elect under Article 45.0511, Code of Criminal Procedure, to take a driving safety course.

I understand that I must present to the Court in person or mail the following with this request:

- A valid Texas driver's license or driver's permit [CDL HOLDERS ARE NOT ELIGIBLE] {or proof that I am a member, or the spouse or dependent child of a member, Of the United States military forces serving on active duty};
- 2. **Proof of financial responsibility** (Automobile liability Insurance) pursuant to Chapter 601, Transportation Code;
- 3. **Payment in the amount of \$144.00** (a reduced fee from the fine shown on ticket); [We will accept cash, money order, or check made payable to Talty Municipal Court]
- 4. Defendant's Plea and Request for a Driving Safety Course, and Affidavit;

I understand that I must:

- 1. Complete a Driving Safety Course, or motorcycle operator training course, as applicable within the <u>90 days of this request</u>.
- Submit by the 90<sup>th</sup> day from this request a Certificate of Completion of a Driving Safety Course, or verification of course completion of a motorcycle operator training course as evidence that I have completed such a course.
- 3. **Submit by the 90<sup>th</sup> day from this request an Affidavit** stating that I am not taking such a course, nor had I completed such a course within the preceding 12 months from the date of my current offense that is not shown on my driving record as maintained by the Texas Department of Public Safety (or if I am on active military duty, or am the spouse or dependent child of a member of the United States military forces service on active duty, that I have not taken a course in another state in the preceding 12 months, nor am I taking such a course at the time of this request); and

4. Submit by the 90<sup>th</sup> day from this request a certified copy of my Texas Driving Record maintained by the Texas Department of Public Safety. [http://www.txdps.state.tx.us/

I understand that:

- If I comply with the Court Order granting the taking of a Driving Safety Course {or motorcycle operator training course} and submit all the required evidence as ordered, the Court will dismiss my case and report to the Texas Department of Public Safety the date that I completed my course for inclusion on my driving record;
- 2. If I fail to submit all the evidence required by this Court, I will be notified of a Show Cause hearing and be required to appear before the Court to Show Cause why I did not present the required evidence of course completion;
- 3. At the time of the show cause hearing, the Judge may enter a final adjudication against me and require me to pay the fine in full; and
- 4. The failure to appear at the show cause hearing will result in a final adjudication being entered against me, and I will be required to pay the fine and any additional costs required by law.

BY SIGNING THIS DOCUMENT, I ATTEST that I have read and understand this document, that I am eligible for the Driving Safety Course, and I do hereby PLEAD NO CONTEST to the offense as charged, waived my right to a trial by jury or hearing by the Court, and request the Court to grant my request to take the Driving Safety Course for the citation listed above. You may take a "State Approved" course anywhere in the State of Texas.
